# **Uniform Group Insurance Program**

- Bill No. 78 creates a new trust of prescription drug coverage under the uniform group insurance program and changes provisions relating to the employer payment of unused sick and annual leave, minimum life insurance benefits coverage, retiree health benefits fund, employer payments of a temporary employee's health insurance premium, temporary employee eligibility, and bids for prescription drug coverage (PERS)
- Bill No. 62 allows public health districts to participate in the uniform group insurance program under the same conditions as a state agency (Representative Price)
- Bill No. 30 expands the uniform group insurance program to allow participation by members of the North Dakota National Guard (Senator Mathern)
- Bill No. 31 expands the uniform group insurance program to allow participation by permanent employees of nonprofit organizations (Senator Mathern)
- Bill No. 32 expands the uniform group insurance program to allow participation by employees of small private sector employers (Senator Mathern)
- Bill No. 100 expands the uniform group insurance program to allow participation by other North Dakota residents without health insurance coverage (Senator Mathern)
