## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

3 SECTION 1. APPROPRIATION - STATE EMPLOYEE COMPENSATION. The sums

hereinafter listed, or so much of the sums as may be necessary, are appropriated from the

general fund and from special funds or moneys derived from federal funds or other income in

the state treasury, not otherwise appropriated, as indicated to the agencies and institutions of

state government for the purpose of providing compensation adjustments to employees of the

various agencies and institutions in accordance with section 2 of this Act, for the biennium

beginning July 1, 2005, and ending June 30, 2007. 9

## 18 SECTION 2. LEGISLATIVE INTENT - STATE EMPLOYEE COMPENSATION

- 19 **ADJUSTMENTS GUIDELINES.** It is the intent of the fifty-ninth legislative assembly that
- 20 2005-07 compensation adjustments for permanent state employees are to be increases of four
- 21 percent, beginning with the month of July 2005, to be paid in August 2005, and four percent,
- 22 beginning with the month of July 2006, to be paid in August 2006, subject to the following
- 23 limitations:

- Employees whose documented performance levels do not meet standards are not eligible for the general increases.
  - Probationary employees are not entitled to the general increases. However, probationary employees may be given all or a portion of the increases upon completion of probation, at the discretion of the appointing authority.
- During the biennium, no salary increase other than the four percent in July 2005
  and the four percent in July 2006 may be given to an employee whose salary
  exceeds or would exceed the salary range maximum.
