## 8 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 9 SECTION 1. AMENDMENT. Section 17-03-01 of the North Dakota Century Code is
  10 amended and reenacted as follows:
- 17-03-01. Definitions. In this chapter, unless the context or subject matter otherwise
  requires:
- "Biodiesel production facility" means a producer of a biodegradable, combustible
   liquid fuel that is derived from vegetable oil or animal fat and which is suitable for
- 15 blending with diesel fuel for use in internal combustion diesel engines fuel
- 16 composed of mono-alkyl esters of long chain fatty acids derived from vegetable oil
- 17 or animal fats that meets American society for testing and materials specification
- 18 <u>D 6751</u>. The facility must be located in this state and:
- Agricultural producers must hold at least ten percent of the ownership interest
   in the facility; or
- 21 b. Residents of this state must own at least fifty percent of the ownership interest
   22 of the facility.
- 23 2. "Biofuel partnership in assisting community expansion fund" or "fund" means a
  24 fund established to buy down the interest rate on loans to biodiesel and, ethanol,

- 25 **54-17.7-02. Definitions.** As used in this chapter:
- "Authority" means the industrial commission acting as the North Dakota pipeline
   authority.
- 28 2. "Commission" means the North Dakota industrial commission.
- 3. "Energy-related commodities" means any substance, element, or compound, either
   gaseous, liquid, or solid, associated with the production, refining, or processing of
   renewable energy, crude oil, natural gas, coal, or coal byproducts, including oil,

1	natural gas liquids, refined petroleum products, carbon dioxide, hydrogen, ethanol,
2	propane, butane, ethane, methane, sulfur, helium, synthetic fuels, nitrogen,
3	biodiesel, green diesel, and liquids made from coal.

- 4 4. "Natural gas" means hydrocarbons or nonhydrocarbons that at atmospheric
  5 conditions of temperature and pressure are in a gaseous phase.
- 5. "Notice of intent" means the notice a person delivers to the authority indicating
  willingness to construct pipeline facilities contemplated by the authority or to
  provide services fulfilling the need for such pipeline facilities.
- 9 6. "Pipeline facilities" means pipelines, pumps, compressors, storage, and all other 10 facilities, structures, and properties incidental and necessary or useful in the 11 interconnection of pipelines or the transportation, distribution, and delivery of 12 energy-related commodities to points of sale or consumption or to the point or 13 points of distribution for consumption located within and without this state.
- "Project area" means the geographic area in which construction of a pipeline
   facility contemplated by the authority is likely to occur.
- SECTION 7. AMENDMENT. Section 54-44.5-09 of the North Dakota Century Code is
   amended and reenacted as follows:

18 54-44.5-09. Office of renewable energy and energy efficiency. The office of 19 renewable energy and energy efficiency is established within the division of community 20 services. The office shall assist in the development of renewable energy within this state to 21 provide secure, diverse, sustainable, and competitive renewable energy supplies and promote 22 the conservation of energy and the wise use of energy resources in both the public and private 23 sectors. The office shall communicate and disseminate information concerning state and 24 federal energy conservation and renewable energy incentives, including tax credits, financing, 25 and grants to business entities seeking to invest in wind-generated power and transmission, 26 ethanol production and distribution;, and the development of biodiesel, green diesel, biomass, 27 solar, hydropower, geothermal, and other renewable energy sources. The office also shall also 28 manage and distribute all production incentive payments as authorized by chapter 17-02. 29 SECTION 8. AMENDMENT. Section 57-38-01.22 of the North Dakota Century Code is

1 57-38-01.22. Income tax credit for blending of biodiesel fuel or green diesel fuel. 2 A fuel supplier licensed pursuant to section 57-43.2-05 who blends biodiesel fuel or green 3 diesel fuel is entitled to a credit against tax liability determined under section 57-38-30 or 4 57-38-30.3 in the amount of five cents per gallon [3.79 liters] of biodiesel fuel or green diesel 5 fuel of at least five percent blend, otherwise known as B5. For purposes of this section, 6 "biodiesel" means and "green diesel" mean fuel meeting the specifications adopted by the 7 American society for testing and materials as defined in section 57-43.2-01. The credit under 8 this section may not exceed the taxpayer's liability as determined under this chapter for the 9 taxable year and each year's unused credit amount may be carried forward for up to five 10 taxable years.

A partnership, subchapter S corporation, limited partnership, limited liability company, or any other passthrough entity entitled to the credit under this section must be considered to be the taxpayer for purposes of this section, and the amount of the credit allowed must be determined at the passthrough entity level. The amount of the total credit determined at the entity level must be passed through to the partners, shareholders, or members in proportion to their respective interests in the passthrough entity.

SECTION 9. AMENDMENT. Section 57-38-01.23 of the North Dakota Century Code is
amended and reenacted as follows:

19 57-38-01.23. Income tax credit for biodiesel or green diesel sales equipment 20 **costs.** A seller of biodiesel fuel or green diesel fuel is entitled to a credit against tax liability 21 determined under section 57-38-30 or 57-38-30.3 in the amount of ten percent per year for five 22 years of the biodiesel or green diesel fuel seller's direct costs incurred after December 31, 23 2004, to adapt or add equipment to a facility, licensed under section 57-43.2-05, to enable the 24 facility to sell diesel fuel containing at least two percent biodiesel fuel or green diesel fuel by 25 volume. For purposes of this section, "biodiesel fuel" means and "green diesel fuel" mean fuel 26 meeting the specifications adopted by the American society for testing and materials as defined 27 in section 57-43.2-01. The credit under this section may not exceed a taxpayer's liability as 28 determined under this chapter for the taxable year and each year's unused credit amount may 29 be carried forward for up to five taxable years. A biodiesel or green diesel fuel seller is limited 30 to fifty thousand dollars in the cumulative amount of credits under this section for all taxable 31 years. A biodiesel or green diesel fuel seller may not claim a credit under this section for any

7 57-38-30.6. Corporate income tax credit for biodiesel or green diesel production 8 or soybean and canola crushing facility equipment costs. A taxpayer is entitled to a credit 9 against tax liability determined under section 57-38-30 in the amount of ten percent per year for 10 five years of the taxpayer's direct costs incurred after December 31, 2002, to adapt or add 11 equipment to retrofit an existing facility or construction of a new facility in this state for the 12 purpose of producing or blending diesel fuel containing at least two percent biodiesel fuel or 13 green diesel fuel by volume or of the taxpayer's direct costs incurred after December 31, 2008, 14 to adapt or add equipment to retrofit an existing facility or construction of a new facility in this 15 state for the purpose of producing crushed soybeans or canola. For purposes of this section, 16 "biodiesel" means and "green diesel" mean fuel meeting the specifications adopted by the 17 American society for testing and materials as defined in section 57-43.2-01. The credit under 18 this section may not exceed the taxpayer's liability as determined under this chapter for the 19 taxable year and each year's credit amount may be carried forward for up to five taxable years. 20 A taxpayer is limited to two hundred fifty thousand dollars in the cumulative amount of credits 21 under this section for all taxable years. A taxpayer may not claim a credit under this section for 22 any taxable year before the taxable year in which the facility begins production or blending of 23 diesel fuel containing at least two percent biodiesel fuel or green diesel fuel by volume or 24 begins crushing soybeans or canola, but eligible costs incurred before the taxable year 25 production, blending, or crushing begins may be claimed for purposes of the credit under this 26 section for taxable years on or after the taxable year production, blending, or crushing begins. 27 SECTION 12.
