Bismarck, February 12, 2009

The House convened at 12:30 p.m., with Speaker Monson presiding.

The prayer was offered by Matthew Voorhees, Executive Director North Dakota Teen Challenge, Mandan.

The roll was called and all members were present except Representatives Berg, Froelich, S. Kelsh, Kerzman, and Wieland.

A quorum was declared by the Speaker.

**CORRECTION AND REVISION OF THE JOURNAL**

Good afternoon, and welcome to this historic event as we commemorate the 200<sup>th</sup> birthday of one of this country's greatest Presidents - Abraham Lincoln - a remarkable leader who unified a nation and upheld the ideals of freedom, democracy and equal opportunity for all.

One hundred years ago today, Lieutenant Governor R. S. Lewis and members of the 11<sup>th</sup> North Dakota Legislative Assembly held a similar program on these very grounds to mark Lincoln's 100<sup>th</sup> birthday. Teddy Roosevelt was finishing his second term as President at the time.

Since then, North Dakota has seen the burning and rebuilding of its Capitol building, has significantly grown and diversified its economy to become a prominent player in the global marketplace, and has capitalized on cutting-edge technology and advancements.

Our country has fought in two world wars, has seen the advent of radio and television, computers and space travel, and has become a leading force on the world stage. But with all the progress and development that has changed our way of life throughout the past century, we gather here again today, united by the same ideals as those who came before us - inspired by a frontier lawyer who became the 16<sup>th</sup> President of the United States and went on to leave an indelible mark on our state, our nation and the world.

Even though Lincoln never visited what is now North Dakota, our state has been not only changed, but shaped by the policies and laws enacted during his presidency.

The signing of the Homestead Act in 1862 and the charter for the Northern Pacific Railroad in 1864 brought pioneers to the Northern Plains and led to the settlement of towns and cities, many of which are growing and thriving today.

The Morrill Land Grant College Act, signed by Lincoln in 1862, founded what is now North Dakota State University, a premier education and research institution specializing in agriculture, engineering and technology.

He also appointed the first two Governors of the Dakota Territory, part of which later became North Dakota.

Today, we celebrate what Lincoln represents, not only to Americans, but to people throughout the world - freedom, democracy and equality, as well as kindness, integrity and courage.

Lincoln's extraordinary leadership and transforming accomplishments as President significantly shaped our state and reunified our nation. He strengthened the underlying purpose of government as an institution "of the people, by the people, for the people."

With the belief that all men are created equal, he led the national effort to free all slaves in the United States. Delivering his immortal speech in Gettysburg, Pennsylvania, on November 19, 1863, he invoked the basic principles of human equality as outlined in the Declaration of Independence.

His strength of character redefined the objective of the American Civil War from saving the Union to fostering "a new birth of freedom."

Despite the tragedy and turmoil of the Civil War, Abraham Lincoln demonstrated through words and actions a generosity of heart and greatness of character that generated a spirit of reconciliation - with "malice toward none and charity for all."

In his own words, Lincoln said, "the assertion that all men are created equal was of no practical use in effecting our separation from Great Britain and it was placed in the Declaration not for that, but for future use."

That is an ideal he admirably upheld through both word and deed - an ideal that will continue to impact future generations.

Now, it is my pleasure to introduce students from the fourth grade class at Fort Lincoln Elementary in Mandan. Additional students representing schools across the state named for President Abraham Lincoln were unable to be here today as a result of the weather.

But just as Lincoln's enduring words from his Gettysburg Address were read during the Joint Session 100 years ago, these students will today recite the speech that changed the course of our nation's history.

Welcome, students.

**NDSU PRESIDENT JOSEPH A. CHAPMAN**  
**Address to a Joint Session of the North Dakota Legislature**  
**February 12, 2009**

Governor Hoeven, Mr. President, Mr. Speaker, Members of the Joint Assembly. Thank you for giving me this opportunity.

Two hundred years ago in a log cabin in Kentucky, a boy named Abraham was born. Like other boys of his time, he worked with his father, but did not have the opportunity to attend school. As he grew, he accumulated less than a year of formal education. But he hungered for education, and did what he could to teach himself, and when Abraham Lincoln rose to the highest position in our government, he signed the Morrill Act that established Land Grant Universities.

This was a truly groundbreaking move to provide access to a new kind of education to millions of people never before offered such opportunity.

Lincoln understood that education was the key to the future of this country, and believed providing opportunity to individuals would in turn improve the lives of all Americans. He once said: "Upon the subject of education ... I can only say that I view it as the most important subject which we as a people may be engaged in."

Lincoln believed in what has been called the People's University.

The key language of the Morrill Act is this: "The object shall be, without excluding other scientific and classical studies, and including military tactics, to teach such branches of learning as are related to agriculture and the mechanic arts ... to promote the liberal and practical education of the industrial classes." Education had never before encompassed agriculture and engineering, had never before sought to include any but the elite. This was a radical view in 1862.

We at North Dakota State University are, at all times, mindful of our mission as North Dakota's original Land Grant university and the ideals we are privileged to carry out.

North Dakota signed its Land Grant Act into law and established North Dakota Agricultural College in 1890. Over the ensuing 119 years, North Dakota State University has educated thousands of people, contributed millions in economic development, improved crops for people around the world, and much more, all in close partnership with the people of North Dakota. We are very proud today to have students from every county in the state attending North Dakota State University.

It is fitting that we remember and celebrate this historic day, and pause to appreciate the legacy of this legislation signed by Lincoln, who was President at perhaps the darkest time in the country's history.

The intent to provide opportunity has been enhanced several times over the years. In 1890, Congress passed the Second Morrill Act creating black land-grant colleges and universities, and in 1994, 33 Tribal Colleges became land-grant institutions. Land Grant universities also were enhanced by the 1887 Hatch Act, which provided for research stations, and the Smith-Lever Act of 1914, which established the Extension Services.

In service to our Land Grant mission, we continue to prepare students and citizens for the future. Our work today--to prepare students for and assist business with the global marketplace--is the 21<sup>st</sup> century version of the land-grant ideal.

As we take this day to honor Abraham Lincoln on the historic 200-year anniversary of his birth, I ask you to join together in honoring one of his many enduring visions--that of the land-grant university. Let us look to the future as Lincoln did himself and continue to serve the people of North Dakota. Thank you.

It's my pleasure to introduce to you now our special guest this afternoon, President Abraham Lincoln as portrayed by George Frein. Dr. Frein taught in the philosophy and religion department at the University of North Dakota from 1968 to 1997, and has presented a variety of Chautauqua characters over the years.

### Lincoln for North Dakota Legislature

It is a great piece of folly to attempt to make anything out of my birth or life. It can all be condensed into a single sentence, and that sentence you will find in Gray's Elegy: "The short and simple annals of the poor." That is my life, and that is all anyone can make of it. At least that is what I told John Locke Scripps, the Chicago editor, when he proposed to write my campaign biography five years ago in 1860.

So today, though it is my [56<sup>th</sup>] birthday, I will not attempt the folly of biography. Rather, at the urging of my good friend, Dr. William Jayne, the first Governor of Dakota Territory, I gladly accept the invitation of the present Governor, Newton Edmunds, to give a brief address to the legislature of Dakota.

Let me be somewhat philosophical in this address. Let me also follow my usual practice of gathering together thoughts I have previously written, some published some unpublished.

Governor Jayne once complained of the rowdiness of the Dakota legislature, so knowing that I will begin with a sedate thought about legislative and governmental purpose. The legitimate object of government, is to do for a community of people, whatever they need to have done, but cannot do or cannot do well for themselves in their separate, and individual capacities. In all that the people can do individually for themselves, government ought not to interfere. Now the desirable things which individuals cannot do well for themselves, require combined action, such as public roads and highways, public schools, charities, orphanage, the administration of justice, and the machinery of government itself.

To this list I would add a state bank. When I was in the Illinois Legislature some years ago, Jacksonian Democrats, led by Stephen A. Douglas, assailed the State Bank, claiming that it was a tool of elitist financiers--mostly Whigs--like myself. I spoke in defense of the Bank as a fair, constitutional, and indispensable institution. On the floor of the legislature, I said: "Mr. Chairman, this movement against the Bank is exclusively the work of politicians; that is to say, a set of men who have interests aside from the interests of the people, and who are--taken as a whole--at least one long step from honest men. Now I say this with great freedom because, being a politician myself, none can regard it as personal." I am happy to say that the Illinois Legislature continued the Bank's operation for the benefit of the people of Illinois.

The people of Dakota, I am sure, are like the people of Illinois and one important likeness has been remarked upon by Governor Jayne in his address to the first session of the territorial legislature when he noted that the fertility of the soil in Dakota was like that of central Illinois and he went on to predict that the wheat granary of the continent will be found in the valley of the Red River.

I hope that prediction comes true in Dakota for many are the benefits of agriculture to a territory. I said as much to a crowd at an agricultural fair in Wisconsin a few years ago. Waxing somewhat philosophical I said this:

**"No other human occupation opens so wide a field for the profitable and agreeable combination of labor and thought as agriculture does. How vast a field is agriculture for the discovery of what is new and valuable! The mind already trained to careful thought in the country school, or higher school, cannot fail to find there an exhaustless source of profitable enjoyment."**

Then waxing poetical I said:

**"Every blade of grass is a study;**

**And to produce two,**

**Where there was but one,**

**Is both a profit and a pleasure.**

**And not grass alone;**

**But soils, seeds, and seasons**

**Hedges, ditches, and fences,**

Draining, droughts, and irrigation--

Plowing, hoeing, and harrowing--

Reaping, mowing, and threshing--

Saving crops, pest of crops, diseases of crops,

And what will prevent or cure them--

Implements, utensils, and machines,

Their relative merits,

And [how] to improve them--

Hogs, horses, and cattle--

Sheep, goats, and poultry--

Trees, shrubs, fruits, plants, and flowers--

The thousand things

Of which these are specimens--

Each a world of study within itself."

The mechanical branches of Natural Philosophy are a ready help in almost everything. The thought recurs that education can best be combined with agricultural labor, or any labor, on the principle of thorough work. And this conforms to what must occur in a world less inclined to wars, and more devoted to the arts of peace, than heretofore. Population will increase rapidly--more rapidly than in former times--and ere long the most valuable of all arts, will be the art of deriving a comfortable subsistence from the smallest area of soil. No community, whose members possess this art, can ever be the victim of oppression in any of its forms. Such a community will be independent of crowned-kings, money-kings, and land-kings.

I should add slave-masters to that list as we are now engaged in a civil war that will soon overthrow the slave oligarchs. How plain it is that the most dumb and stupid slave that ever toiled for a master, does constantly **know** that he is wronged. So plain is it that no one, high or low, ever does mistake it, except in a plainly **selfish** way; for although volume upon volume is written to prove slavery a very good thing, we never hear of the man who wishes to have the good of it, **by being a slave himself**.

Most **governments** have been based on the denial of the equal rights of men; **ours** began, by **affirming** those rights. Our critics said, some men are to **ignorant**, and **vicious**, to share in government. Possibly so, said we; and, by your system, you would always keep them ignorant, and vicious. We proposed to give **all** an unfettered chance; and we expect the weak to grow stronger, the ignorant to grow wiser; and all to grow better and happier together.

We want, as I said in my address at Gettysburg last year "a new birth of freedom--that government of the people, by the people, for the people, shall not perish from the earth."

We want the states to ratify the 13<sup>th</sup> Amendment to the Constitution abolishing slavery in every state of this republic forever.

We want "with malice toward none; with charity for all ... to finish the work we are in ... to bind up the nation's wounds ... to do all which may achieve a just and lasting peace."

It is said an Eastern monarch once charged his wise men to invent him a sentence, to be ever in view, and which should be true and appropriate in all times and situations. They presented him these words: "And this, to, shall pass away." How much it expresses! How chastening in the hour of pride! How consoling in the depths of affliction! "And this, too, shall pass away." And yet, let us hope it is not quite true. Let us hope, rather, that by the best cultivation of the physical world, beneath and around us; and the intellectual and moral world within us, we shall secure an individual, social, and political prosperity, whose course shall be onward and upward, and which, while the earth endures, shall not pass away.

We want legislatures--whether rowdy or sedate--which will labor to this purpose.

I now bid you the best of good fortune in your work which is the "government of the people, by the people, for the people, shall not perish from the earth."

The financial statement must set forth the financial condition of the professional employer organization over the most recent twelve month operating period and must clearly define the working capital of the professional employer organization. A professional employer organization that has not had sufficient operating history to have a financial statement based upon at least twelve months of operating history shall meet the financial capacity requirements under this chapter and present a financial statement bond as provided under this subdivision for the entire period of its operation section 43-55-05.
- j. A copy of the employer's quarterly federal tax return for the quarter ending immediately before the date submitted to the secretary of state. A professional employer organization that has not operated long enough to have filed an employer's quarterly federal tax return shall submit a bond in the amount as provided under section 43-55-05.

**Interagency cooperation.** A state agency, in performing duties under other laws that affect the regulation of professional employer organizations, shall cooperate with the secretary of state as necessary to administer and enforce this chapter."

Notwithstanding any other provision of law, the board of a school district may not enter an agreement pursuant to internal revenue service revenue ruling 63-20 under which payments of any kind would be required by the district to any building authority or other entity that incurs indebtedness or other obligation in connection with the acquisition, improvement, or construction of any property or structure to be used by the district, unless the agreement has been approved by a vote of at least sixty percent of the qualified electors of the district voting on the question if the acquisition, improvement, or construction subject to the agreement would require an election were the acquisition, improvement, or construction undertaken by the district through the issuance of bonds.
2. The board of a school district may not enter an agreement pursuant to internal revenue service revenue ruling 63-20 under which payments of any kind would be required by the district to any building authority or other entity that incurs indebtedness or other obligation regarding the construction, purchase, improvement, modernization, or renovation of any building or facility to be used by the district without the approval of the

superintendent of public instruction under section 15.1-36-01, if approval by the superintendent would be required were the project undertaken by the district itself."
