ENGROSSED SENATE BILL NO. 2001

Introduced by

Appropriations Committee

(At the request of the Legislative Management)

1 A BILL for an Act providing an appropriation for defraying the expenses of the legislative branch
2 of state government; to provide for applications, transfers, and cancellation of unexpended
3 appropriations; to create and enact a new section to chapter 54-35 of the North Dakota Century
4 Code, relating to hosting out-of-state dignitaries; to amend and reenact ~~sections~~subsections 1,
5 2, and 7 of section 54-03-20 and section 54-35-10 of the North Dakota Century Code, relating
6 to legislative compensation and expense reimbursement; to provide legislative intent; to provide
7 an effective date; to provide for retroactive application; and to declare an emergency.

8 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

9 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
10 as may be necessary, are appropriated out of any moneys in the general fund in the state
11 treasury, not otherwise appropriated, and from special funds derived from the insurance
12 regulatory trust fund, not otherwise appropriated, to the legislative branch of state government
13 for the purpose of defraying the expenses of that branch, for the fiscal period beginning with the
14 effective date of this Act and ending June 30, 2015, as follows:

16 sixty-fourth legislative assembly on the use of this one-time funding for the biennium beginning
17 July 1, 2013, and ending June 30, 2015.

2 2015-17 biennium. The legislative council shall report to the appropriations committees of the
3 sixty-fourth legislative assembly on the use of this one-time funding for the biennium beginning
4 July 1, 2013, and ending June 30, 2015.

5 **SECTION 4. TRANSFERS.** Notwithstanding section 54-16-05, the director of the office of
6 management and budget and the state treasurer shall make transfers of funds between line
7 items of appropriations for the legislative management and legislative council as may be
8 requested by the chairman of the legislative management or the chairman's designee upon the
9 finding by the chairman or designee that the nature of studies and duties assigned to the
10 legislative management or legislative council requires the transfers in properly carrying on the
11 legislative management's and legislative council's functions and duties. The director of the office
12 of management and budget and the state treasurer shall similarly make transfers of funds
13 between the line items for the sixty-third and sixty-fourth legislative assemblies, upon request by
14 the chairman of the legislative management or the chairman's designee upon the finding by the
15 chairman or designee that the transfers are required for the legislative assembly to carry on its
16 functions and duties.

17 **SECTION 5. APPLICATION, TRANSFER AUTHORITY, AND CANCELLATION OF**
18 **UNEXPENDED APPROPRIATIONS.** Sections 54-16-04 and 54-44.1-11 do not apply to
19 chapter 1 of the 2011 Session Laws. The director of the office of management and budget and
20 the state treasurer shall make transfers of funds between the line items and the agencies of the
21 legislative branch within section 1 of that chapter as requested by the chairman of the legislative
22 management or the chairman's designee. The office of management and budget shall cancel
23 unexpended appropriations for the legislative assembly and legislative council enacted prior to
24 the 2011-13 biennium as directed by the chairman of the legislative management or the
25 chairman's designee.

10 attendance at sessions of the legislative management and of its committees at the rate
11 of one hundred ~~fifty-seven~~sixty-two dollars per day and must also be paid for
12 expenses incurred in attending said meetings and in the performance of their official
13 duties in the amounts provided by law for other state officers.
- 14 2. In addition to the compensation provided in subsection 1, the chairman of the
15 legislative management is entitled to receive an additional five dollars for each day
16 spent in attendance at sessions of the legislative management and of its committees,
17 and the chairman of each of the legislative management's committees is entitled to
18 receive five dollars for each day spent in attendance at sessions of the legislative
19 management or of the committee which the person chairs.

20 **SECTION 10. AMENDMENT.** Section 54-35-10 of the North Dakota Century Code is
21 amended and reenacted as follows:

22 **54-35-10. Compensation of members and leadership.**

- 23 1. The members of the legislative management and the members of any committee of
24 the legislative management are entitled to be compensated for the time spent in
25 attendance at sessions of the legislative management and of its committees at the rate
26 of one hundred ~~sixty-two~~sixty-seven dollars per day and must also be paid for
27 expenses incurred in attending said meetings and in the performance of their official
28 duties in the amounts provided by law for other state officers.
- 29 2. In addition to the compensation provided in subsection 1, the chairman of the
30 legislative management is entitled to receive an additional five dollars for each day
31 spent in attendance at sessions of the legislative management and of its committees,

1 and the chairman of each of the legislative management's committees is entitled to
2 receive five dollars for each day spent in attendance at sessions of the legislative
3 management or of the committee which the person chairs.

4 **SECTION 11.** A new section to chapter 54-35 of the North Dakota Century Code is created
5 and enacted as follows:

6 **Legislative hosting of dignitaries.**

7 The legislative management or the chairman of the legislative management may approve
8 the hosting of out-of-state dignitaries on behalf of the legislative assembly and may authorize
9 the majority and minority leaders of the senate and the house of representatives or their
10 designees to assist in the hosting of such dignitaries. An expenditure for the purchase of items
11 to promote or to host a dignitary under this section may not be construed as a gift for purposes
12 of section 18 of article X of the Constitution of North Dakota. The provisions of chapter 44-08 do
13 not apply to expenditures made under this section.

14 **SECTION 12. LEGISLATIVE INTENT.** It is the intent of the sixty-third legislative assembly
15 that the legislative management not proceed with implementing a process to record and archive
16 video of standing committee meetings during the legislative session for the biennium beginning
17 July 1, 2013, and ending June 30, 2015.

18 **SECTION 13. LEGISLATIVE INTENT.** It is the intent of the sixty-third legislative assembly
19 that the legislative management consider implementing during the sixty-fourth legislative
20 assembly a limited bill analysis report pilot project to provide bill analysis reports similar to
21 analysis reports prepared in other states.

22 **SECTION 14. EFFECTIVE DATE.** Sections 6 and 8~~9~~ of this Act become effective on July 1,
23 2013, and sections 7 and 9~~10~~ become effective on July 1, 2014.

24 **SECTION 15. RETROACTIVE APPLICATION.** Section 8 of this Act applies retroactively to
25 January 1, 2013.

26 **SECTION 16. EMERGENCY.** This Act is declared to be an emergency measure.
