# **SECOND READING OF SENATE BILL**

**SB 2223:** A BILL for an Act to create and enact a new section to chapter 57-39.2 of the North Dakota Century Code, relating to a sales and use tax exemption for clothing; and to provide an effective date.

#### **MOTION**

- Page 1, line 2, after the semicolon insert "to provide a statement of legislative intent; to provide an appropriation;"
- Page 1, line 7, after "clothing" insert "-Allocation of replacement revenue to cities and counties"
- Page 1, line 9, after the underscored period insert "The commissioner shall make annual allocations of funds provided by legislative appropriations among cities and counties imposing sales taxes to offset the lost city and county sales tax revenue from this exemption. The commissioner shall make an annual payment to cities and counties prorated in proportion to the respective shares of each city and county in respect to total annual statewide city and county home rule sales tax collections."

Page 4, after line 27, insert:

"SECTION 2. APPROPRIATION - LEGISLATIVE INTENT. There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$14,000,000, or so much of the sum as may be necessary, to the tax commissioner for the purpose of allocation to cities and counties under section 1 of this Act. Two-thirds of the amount appropriated shall be allocated in two equal annual installments to cities and counties for the biennium beginning July 1, 2015, and ending June 30, 2017. It is the intent of the sixty-fourth legislative assembly that the remaining one-third of the amount appropriated will be appropriated by the sixty-fifth legislative assembly for allocation to cities and counties for the biennium beginning July 1, 2017, and ending June 30, 2019."

All taxes, license fees, penalties, and interest collected under this chapter must be transferred to the state treasurer who shall deposit moneys in a highway tax distribution fund, except all special fuels excise taxes collected on sales of diesel fuel to a railroad under section 57-43.2-03 of up to five hundred thousand dollars per year must be transferred to the state treasurer who shall deposit the moneys in the rail safety fund. The highway tax distribution fund must be distributed in the manner as prescribed by section 54-27-19.

**SECTION 7. EFFECTIVE DATE.** Section 6 of this Act is effective for special fuels excise taxes collected after June 30, 2015.

**SECTION 8. RETROACTIVE APPLICATION.** The specialized legal services line item in section 1 of this Act is retroactive in application.

**SECTION 9. EMERGENCY.** The specialized legal services line item in section 1 of this Act is declared to be an emergency measure."
