1 A BILL for an Act to provide an appropriation for defraying the expenses of the judicial branch;
2 and to provide a transfer.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
5 as may be necessary, are appropriated out of any moneys in the general fund in the state
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and
7 other income, to the judicial branch for the purpose of defraying the expenses of the judicial
8 branch for the biennium beginning July 1, 2017, and ending June 30, 2019, as follows:

24 **SECTION 3. APPROPRIATION.** There are appropriated any funds received by the
25 supreme court, district courts, and judicial conduct commission and disciplinary board, not
26 otherwise appropriated, pursuant to federal acts and private gifts, grants, and donations for the
27 purpose as designated in the federal acts or private gifts, grants, and donations for the period
28 beginning July 1, 2017, and ending June 30, 2019.

29 **SECTION 4. TRANSFERS.** The director of the office of management and budget and the
30 state treasurer shall make such transfer of funds between line items of appropriation for the
31 judicial branch of government as may be requested by the supreme court upon a finding by the
