- 1 A concurrent resolution directing the Legislative Management to consider studying the factors
- 2 contributing to the nation's firearm and ammunition shortage and the impact the shortage has
- 3 had on the quality of life for North Dakota citizens.
- 4 **WHEREAS**, the firearm and ammunition inventory of wholesalers and distributors, which is

5 at a historic low, is not due to a shortage in materials; and

- 6 WHEREAS, while firearm and ammunition retailers, wholesalers, and distributors had piles
 7 of inventory in January 2020, by December 2020, the same racks and shelves were empty; and
- 8 WHEREAS, with an election year that has had significant consequences for gun rights, a
- 9 global pandemic event, rioting in cities and urban centers throughout the United States, there is
- 10 an unprecedented demand for self-defense tools; and
- 11 WHEREAS, the firearm and ammunition shortage directly impacts the personal protection
- 12 <u>capabilities and safety of North Dakota citizens and the ability of law enforcement and military</u>
- 13 personnel to perform their essential duties; and
- 14 WHEREAS, North Dakota is one of the gun-friendliest states in the nation, a state in which
- 15 gun rights and hunting are sacred so the firearm and ammunition shortage negatively impacts
- 16 <u>hunting, fishing, and predator control within the state;</u> and
- 17 WHEREAS, the Legislative Assembly should work to ensure the supply and price of
- 18 firearms and ammunition remains stable in North Dakota;

19 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF

20 NORTH DAKOTA, THE SENATE CONCURRING THEREIN:

- 21 That the Legislative Management consider studying the factors contributing to the nation's
- 22 current firearm and ammunition shortage and the impact the shortage has had on the quality of
- 23 life for North Dakota citizens; and

- 1 **BE IT FURTHER RESOLVED**, that the Legislative Management develop a plan of action to
- 2 resolve the state's current firearm and ammunition shortage; and
- 3 **BE IT FURTHER RESOLVED**, that the Legislative Management report its findings and
- 4 recommendations, together with any legislation required to implement the recommendations, to
- 5 the Sixty-eighth Legislative Assembly.
