OTHER INFORMATION

Chairman O'Brien called on Ms. Lindsey Slappy, Audit Manager, State Auditor's office, who presented a report entitled <u>State of North Dakota Office of the State Auditor External Peer Review for the Period April 1, 2022 Through</u> <u>March 31, 2023</u>. Ms. Slappy noted the peer review was conducted by the National State Auditor's Association and the State Auditor's office received the highest rating possible which is "pass."

In response from a question from a committee member, Ms. Slappy provided information relating to the State Auditor's office external peer review. She noted the local government audits involved in the peer review were Grand Forks County, LaMoure County, Morton County, and Williston Public Schools.

Chairman O'Brien called on Mr. Dan Cox, Quality Control Manager, State Auditor's office, who provided information (<u>Appendix C</u>) on the State Auditor's office plan for meeting the requirements of House Bill No. 1508 (2023) regarding communications with clients, billings, audits performed, and audit schedule.

In response to questions from committee members, Ms. Slappy provided information relating to the average bill rates per staff member for contracted audits. She noted an average rate per hour of \$153 and \$156 from two prior audit proposals.

ATTORNEY GENERAL LEASED FACILITY INVESTIGATIVE REPORT

Chairman O'Brien called on Mr. Drew H. Wrigley, Attorney General, who provided information on the status of the investigation relating to the Attorney General facility lease agreement and cost overruns. He offered background information and timeline of lease agreement matters and noted further investigation is awaiting referral to a State's

Attorney office. He noted the email accounts of the prior Attorney General and Deputy Attorney General were deleted by the Information Technology Department at the request of the prior executive assistant and, subsequently, the prior executive assistant's email account was removed based on records retention protocols.

Chairman O'Brien called on Mr. Don Guiberson, Agent, Montana Department of Justice, who commented on the <u>Montana Department of Justice's investigative report</u>. He noted the report was a fact finding investigation.

Chairman O'Brien called on Mr. Monte L. Rogneby, Attorney, Vogel Law Firm, who provided a response for Stealth Properties LLC and D&S LLC (<u>Appendix D</u>) to the investigative report conducted by the Montana Department of Justice.

COMMITTEE DISCUSSION AND STAFF DIRECTIVES

At the request of Chairman O'Brien, Mr. Mertz distributed the Department of Health and Human Services writeoff report for fiscal year <u>2023</u>.

Representative Schauer suggested the committee invite Mr. Troy Seibel, former North Dakota Deputy Attorney General, and Ms. Elizabeth Brocker, former Attorney General Executive Assistant, to appear before the committee regarding the Attorney General facility lease agreement and cost overruns and associated emails.

Committee members suggested the committee receive the following items at future meetings:

- A presentation from the North Dakota State Fair Association relating to corrective action plan for audit findings in the September 30, 2022, financial statements.
- A report from the Legislative Council on emails relating to the Attorney General lease agreement, including the lease arrangements, lease invoice information, and payment reconciliation efforts from the North Dakota Attorney General's office, Montana Department of Justice, and Stealth Properties LLC.
- A presentation of the Barley Council (June 30, 2021 and 2022), Soybean Council (June 30, 2023), and Beef Commission (June 30, 2022 and 2023) audit reports.
