#### REMARKS OF REPRESENTATIVE OSTLIE

**MR. SPEAKER:** Thank you, Mr. Speaker and members of the assembly. We just voted on a resolution to appoint a new poet laureate. I would like to share with the assembly a few things about our previous poet laureate.

Larry Woiwode was born in Carrington ND in 1941 and in 1950 moved to Illinois with his family. His writing career began in New York City and by 1966 he was publishing stories and poetry in The New Yorker. His work also appeared in The Atlantic, Esquire, Harper's, and The Paris Review.

Larry's portrait is on the wall in this building as he is one of the Rough Rider Award recipients in which he was given this honor in 1992.

I met and got to know Larry when he was a professor at the University of Jamestown where he served from 2007-2020. He was then appointed Writer in Residence at the University of Mary where he lectured and taught until his death in April of 2022. One of his final works is a book titled, Dignity of Grace, which recounts the life of Sister Thomas Welder, the fifth president of the University of Mary.

Larry had a lot of pride in his North Dakota roots and he was honored every day of the 27 years he served as the states Poet Laureate.
