Senator David Hogue - Chairman

Minutes:

Senator Nicole Poolman - District 7 - Introduces the bill - See written testimony (1)

Senator Lyson - Asks if this is a new area.

Senator Poolman - Replies that it is her understanding that these records are confidential and Job Service does not share this information with anyone typically. This would be new information that they are sharing.

Thomas Trenbeath - Deputy Attorney General - See written testimony (2)

Senator Hogue - Asks for an outline of the AG's tracking responsibilities under existing law.

Trenbeath - Responds that they do have a list and addresses are changed and registered so that any individual can go on the web site to see where any particular person lives or find a certain vicinity where registered sex offenders live.

Senator Armstrong - Asks how this would be implemented.

Trenbeath - He said they don't yet have an answer; this would be an agreement to go forward in developing a system whereby they can match the two lists.

Senator Sitte - Mentions the e-mails she has received from families that feel this is a black mark forever when people are trying to turn over a new leaf.

Trenbeath - Explains the e-mails they received from people asking where sexual offenders are allowed to reside. He says the idea is to inform the public not control where these people are living.

John Byers - Attorney General's Office - Explains the level of sex offenders.

Senator Sitte - Is concerned with low risk offenders that are treated harshly and not able to get a job verses a high risk. She would like to see a distinction in the bill.

Byers - Replies that our state walks that fine line more than any other state as far as realizing there is a difference between the low risk and high risk offender and do things that reflect that. He goes on to describe what ND does.

Senator Armstrong - Mentions that this bill does not change enforcement but gets people who have been registered elsewhere.

Byers - Responds it allows them to compare data such as people coming from out of state and have not registered here. He explains how the information is reported to Job Service then to his office.

Trenbeath - Explains this is the one way they know to find out consistently that those people who are not registering are here. He wants to maintain the focus of this bill is to match identifying information.

Senator Sitte would like to amend this to only high risk offenders. Senator Hogue asks Senator Lyson to withdraw his motion to which he denies. Senator Hogue believes committee members should be given the opportunity to amend bills.

Chairman Koppelman: Opened hearing on SB 2185

Senator Poolman, District 7: Gave her testimony in support of the bill.

Wayne Stenehjem, Attorney General: (2:10) Spoke in support of the bill.

Rep. Delmore: (4:45) Do employees when they register with Job Service, are they asked this question whether they have a record of any type and required to ask?

Stenehjem: They are not required to ask; they may or may not ask. This bill would do is just to say job services who gets the names of all those people who are coming in, they will compare this to the list of sex offenders.

Rep. Delmore: Would there be a fiscal note on this bill because there will require extra people to do this?

Stenehjem: Job Service says they think they can do it without a fiscal note.

Rep. Klemin: (5:50) Is there an error in the wording on line 11, should the second word, employer, be employee?

Stenehjem: You're right.

Rep. Hogan: Do you know other states that are doing this?

Stenehjem: I do not. Job Service said they would be willing to assist but the law didn't allow it.

Rep. Hogan: Since Job Service is regulated by the federal government, are there any federal concerns with it?

Stenehjem: As I am told, they are comfortable that federal law says they can't release the name unless federal or state law requires it and that's what this bill will do.

Rep. Hanson: Does this law if passed change our current sex offender laws in ND?

Stenehjem: No, anybody who comes is supposed to already be registered under the law. This will better help us find out if they are here.

Rep. Larson: What would this be used for? When you find out they are here will you then notify law enforcement if they haven't registered?

Stenehjem: It will assist law enforcement if they are here and they have not registered as they are required to do, that is a criminal offense in ND. Local law enforcement also likes to check up on them every once in a while when time permits.

Rep. Larson: Will your office be listing these people if you get the names from Job Service on your website?

Stenehjem: Yes, every law enforcement agency reports the list of those sex offenders on NDsexoffender.com.

Rep. Karls: What is the responsibility of an employer who has a block to check on the form, have you ever been convicted of a sexual offense or are you a registered sex offender?

Stenehjem: This office doesn't have anything to do with that. Employers are free to make whatever employment decision is appropriate for that employee.

Rep. Steiner: Do you think the photo id would help rather than just the name?

Stenehjem: For this purpose we only can have Job Service use the information they have. I don't think they require photographs. For the purposes of this bill it's the employment information and information about that individual employee.

Rep. Klemin: When you do these names do you use any other kind of identification such as social security number?

Stenehjem: Yes, we do try to double check.

Rep. Brabandt: How many registered sex offenders do we have in this state?

Stenehjem: About 2000

Rep. Delmore: What are the different classifications?

Stenehjem: We do something unique in ND. Under Federal there is a risk assigned base on nothing except what you managed to plea bargain your case to. We get information on every convicted offender in ND and apply that to the risk assignment.

Rep. Delmore: They all must register in all those categories?

Stenehjem: Everybody must register in all those categories for the sex offenses. The low risk sex offenders don't have all the details the high risk offenders do on the web site.

Rep. Koppelman: Has there been any success in tracking these people without a bill like this and do you think we are getting a handle on this, will this bill help?

Stenehjem: I think it will help. This information is designed for public notification and awareness for mom's and dad's to take whatever action they feel is appropriate to protect their children.

Rep. Boehning: Looking at the website, it lists the juvenile offense, I think those juvenile records were open?

Stenehjem: They are open.

Chairman Koppelman: Further testimony in support of SB 2185, opposition, neutral. Closed the hearing.

Rep. Klemin: I move to amend SB 2185 to delete the word employer and insert the word employee.

Second Rep. Maragos

Chairman Hogue, Members of the Committee:

I am Deputy Attorney General Thomas Trenbeath and I appear on behalf of the Attorney General. I wish to testify in favor of Senate Bill 2185.

One of the collateral consequences of the oil boom in North Dakota is the immigration of workers from other states. Many western counties have seen the number of registered sexual offenders in their jurisdiction triple or quadruple in the last five years. Those figures only take into account the offenders that are legally registered. What we don't have is an accurate picture of the number of sexual offenders who have come to work in North Dakota and who have not registered as the law requires.

Job Service North Dakota is the entity that would have employee information that we can compare to federal databases to attempt to identify offenders who are here and should be registering, but are not. Senate Bill 2185 will also provide the Attorney General a mechanism to confirm whether the employment information that North Dakota registrants have given is accurate.

The Attorney General asks for a do pass on Senate Bill 2185. I would be happy to answer any questions.
