NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO N.D. ADMIN. CODE CHAPTER 75-02-02.1 ELIGIBILITY FOR MEDICAID

TAKE NOTICE that the North Dakota Department of Health and Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code chapter 75-02-02.1 at 2:00 p.m. on Wednesday, September 20, 2023, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code chapter 75-02-02.1, Eligibility for Medicaid, incorporate updates pursuant to 2023 Senate Bill Nos. 2012 and 2181, the Substance Use-Disorder Prevention that Promotes Opioid Recovery and Treatment for Patients and Communities (SUPPORT) Act, and Consolidated Appropriations Act of 2021. Federal law does mandate the proposed rules.

The proposed changes are as follows:

Section 75-02-02.1-01 is amended to update the titles of entities and to remove a defined term that is no longer used.

Section 75-02-02.1-05 is amended to include coverage for the Medicare Immunosuppressive Drug individuals and increase the Children's Health Insurance Program income to 210% of the poverty level pursuant to 2023 Senate Bill No. 2012.

Section 75-02-02.1-10 is amended to provide that for Medicaid eligibility for an individual who enters the state is eligible as of the date they enter the state.

Section 75-02-02.1-16 is amended to clarify that if the Interstate Compact on Placement of Children is silent regarding Medicaid coverage, the child will be considered a resident of the state and to update the correct title of a division within the department.

Section 75-02-02.1-18 is amended to provide that pregnant women who are lawfully present are not subject to the five-year, forty-quarter waiting period

through the twelve months of postpartum coverage pursuant to 2023 Senate Bill No. 2181.

Section 75-02-02.1-22 is amended to include coverage for the Medicare Immunosuppressive Drug individuals and to replace "person" with "individual".

Section 75-02-02.1-33.1 is repealed as there should no longer be any disqualifying transfers that were made prior to February 8, 2006.

Subsection 4 of section 75-02-02.1-33.2 is amended to clarify when the disqualification period would start.

Section 75-02-02.1-40 is amended to update the level for an ineligible community spouse and increase the pregnant women income level to 175% of the poverty level. The personal needs allowance is increased to \$100 pursuant to 2023 Senate Bill No. 2012.

Subsection 5 of section 75-02-02.1-44 is amended to update language based on a defined term.

The proposed amendments are not anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.
