NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO N.D. ADMIN. CODE CHAPTER 75-03-14 FAMILY FOSTER HOME FOR CHILDREN

TAKE NOTICE that the North Dakota Department of Health and Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code chapter 75-03-14 at 9:00 a.m. on Friday, December 15, 2023, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code chapter 75-03-14, Family Foster Home for children, are necessary to comply with 2023 House Bill No. 1091.

The proposed changes are as follows:

Section 75-03-14-01 is amended to add definitions for "authorized licensing agent", "certified foster care provider", "dwelling", "foster care provider", and "identified relative foster care provider"; and to replace "foster children" with "children in foster care"

Section 75-03-14-02 is amended to include reference to all three levels of licensing (license, certification or approval) as well as update terminology to ensure consistency throughout the chapter, to clarify what is required in the application process, to allow the department to grant a two-year license instead of annual, and to update the approval process.

Section 75-03-14-03 is amended to update minimum physical standards for a foster parent's dwelling and to offer clarity to the general dwelling specifications, and update terminology to ensure consistency throughout the chapter.

Section 75-03-14-04 is amended to update to offer clarity to the qualifications of an applicant, provider, or household member residing in a family foster home for children, to allow for physical examination exemption for all identified relatives of a child in foster care, and to update terminology to ensure consistency throughout the chapter.

Section 75-03-14-04.1 is amended to incorporate relevant provisions of sections 75-03-14-07 and 75-03-14-08 into one section and to allow consistency for all foster related licensing programs, to update fingerprint-based criminal background check requirements and processes, to update what is considered a direct bearing offense and when an individual may be sufficiently rehabilitated, to allow an individual to request a review of fingerprint-based criminal background check results, and to update terminology to ensure consistency throughout the chapter.

Section 75-03-14-05 is amended to incorporate relevant provisions of section 75-03-14-06 into one section, to clarify expectations of foster care providers to ensure the health and safety of children placed in their dwelling as well as to emphasize their role as a safety service for the child, and to update terminology to ensure consistency throughout the chapter.

Section 75-03-14-06 is repealed as portions were added to section 75-03-14-05.

Section 75-03-14-07 is repealed as portions were added to section 75-03-14-04.1.

Section 75-03-14-08 is repealed as portions were added to section 75-03-14-04.1.

Section 75-03-14.1-09 is amended to update identified relative requirements and to offer clarity and to update terminology to ensure consistency throughout the chapter.

Section 75-03-14-10 is created to ensure authority to meet the certification needs and standards for applicants interested in offering short-term, emergency shelter or respite care services.

The proposed amendments are not anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.
