## NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO N.D. ADMIN. CODE CHAPTER 75-03-14.1 SHELTER CARE PROGRAM CERTIFICATION

TAKE NOTICE that the North Dakota Department of Health and Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code chapter 75-03-14.1 at 10:30 a.m. on Friday, December 15, 2023, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code chapter 75-03-14.1, Shelter Care Program Certification, are necessary to comply 2023 Senate Bill No. 2051.

The proposed changes are as follows:

**Subsections 6 and 9 of section 75-03-14.1-02** are amended to add language "unless otherwise approved by the department" to allow for flexibility regarding transferring a license from one physical location to another by the same agency, and to remove "each year" as it is redundant.

**Section 75-03-14.1-03** is amended to allow a shelter care program to enter into a financial contract with eligible referral agencies seeking placement into a certified shelter care program.

**Section 75-03-14.1-04** is amended to remove the reference to children in need of service, to require a policy ensuring the safety of all residents in placement, to add reference to nonemployees, where appropriate, and to require shelter care programs to develop policy how a program will proceed when a current employee, former employee, or nonemployee is involved in a child protection assessment, an institutional child protection assessment, or has record of a criminal offense.

**Section 75-03-14.1-05** is amended to include requirements for nonemployees, to update criminal background check requirements, and to add a requirement for a shelter care program to maintain a file for each nonemployee.

**Section 75-03-14.1-05.1** is created to establish the procedures for background check and criminal conviction, effects of agency and employment or placement by an agency for employees and nonemployees, to establish direct bearing offenses and the ability to be deemed sufficiently rehabilitated, to add an individual's right to request a review, and to offer consistency with background check criteria for providers to meet standards of compliance set forth by the Department.

**Section 75-03-14.1-06** is amended to add reference to nonemployees training requirements if the certified shelter care program chooses to utilize nonemployees.

**Section 75-03-14.1-07** is amended to clarify requirements regarding state fire marshal standards, automatic sprinkler systems, carbon monoxide detectors, and smoke alarms, to amend food storage and sanitation standards, and to remove the requirement for a health inspection for food and beverage.

**Section 75-03-14.1-08** is amended to offer clarity regarding timeliness of initial screenings and extension requests.

**Section 75-03-14.1-09** is amended to change "written consent" to "documented consent" and to document in the resident file who the resident was discharged to, date, and location.

**Section 75-03-14.1-11** is amended to add references to nonemployees to the incident and sentinel event reporting requirements if the certified shelter care program chooses to utilize nonemployees.

The proposed amendments are not anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.
